## 'Honda Sweepstakes – Air, Land & Sea Promotion'

## **OFFICIAL RULES**

## NO PURCHASE NECESSARY TO ENTER OR WIN.

Purchase does not increase chances of winning.

- **1. SPONSOR:** The "Honda Sweepstakes Air, Land & Sea Promotion" sweepstakes is sponsored by American Honda Motor, Co., Inc. Any questions, comments or complaints are to be directed to Sponsor. Entry information is owned by Sponsor. You understand you are providing your entry information to the Sponsor. The entry information provided will only be used in the event that entrant is selected as a sweepstakes winner or if the entrant has indicated he/she would like to receive additional information from Sponsor. Any entrant that has indicated that he/she would like to receive additional information from sponsor or American Honda Motor Co. will be contacted by email. The Sponsor will not provide any entry information to a third party.
- 2. **ELIGIBILITY:** No purchase necessary. The sweepstakes is open to legal residents of and located in any of the fifty United States or the District of Columbia (with the exception of Rhode Island and, except any state where this sweepstakes is prohibited by law) Legal residents of Rhode Island are not eligible. Entrants must be at least eighteen (18) years of age or older at time of entry. Employees of Sponsor, related entities, distributors, affiliates, subsidiaries, advertising and promotion fulfillment agencies, retailers, and their immediate families (parent, child, sibling and spouse) and persons living in the same households as such individuals (whether related or not) are not eligible. - **3. SWEEPSTAKES PERIOD:** The sweepstakes entry period begins on April 2<sup>nd</sup> at approximately 9:00 AM Eastern Standard Time and ends on April 7<sup>h</sup>, 2019 at approximately 5:00 PM Eastern Standard Time.
- **4. HOW TO ENTER:** During the sweepstakes period, fans may enter the sweepstakes at the Honda display via Fotozap at Sun 'n Fun International Fly-In & Expo, in Lakeland, FL. In order to receive Fotozap pictures, all entries must include entrant's first and last name, email address, zip code, phone number and agreement to the official rules.

Entrants will be limited to (1) one in person entry via Fotozap at the Honda display per email address for the entire sweepstakes period. Entries in excess of one (1) per email address will be void and disqualified. All entries become the property of Sponsor and will not be acknowledged or returned. False or deceptive entries or acts, as determined by Sponsor in its sole discretion, will render the entrant ineligible. Participants represent and warrant that they have not purchased any kind of device or Internet service in order to submit an entry or participate in and/or enter the sweepstakes. Entrants will have the option to "opt in" to receive subsequent electronic communication from Sponsor and American Honda Motor Co. Opting to receive further information is <u>not</u> a requirement for entry in the sweepstakes nor does it increase chances of winning.
